☐ Original copies of your most recent 2 years W-2's
$\ \square$ If you have a rental property provide your most recent 2 years tax returns with all schedules and current rental agreement
$\Box$ If you are self-employed or receive a 1099, provide your most recent 2 years tax returns with all schedules and a year-to- date profit and loss statement and balance sheet
$\Box$ If you own 25% or more of a corporation, provide the most recent 2 years corporate tax returns with all schedules and a year-to-date profit and loss statement and balance sheet
$\Box$ If you are commissioned, provide your most recent 2 years tax returns with all schedule and year-to-date employee business expenses
☐ Last 2 months' bank statement for all accounts, all pages, including blank pages
$\square$ Most recent retirement or 401k statements, all pages, including blank pages
$\hfill\Box$ If divorced, all papers including marital termination agreement & final decree (signed and recorded by the court)
☐ Original certificate of eligibility and DD 214 (VA loans only)
☐ Information on Real Estate you currently own - Copy of your current mortgage statement or Tax bill and Insurance Declarations Page (if not paid through escrow)
